TERMS OF REFERENCE

PURPOSE

The Project Oversight Committee (POC) provides leadership and ongoing oversight to the Clinical Specialist Radiation Therapist (CSRT) Sustainability Project (the "Project") in alignment with the mission and vision of Cancer Care Ontario (CCO) and in accordance with the Agreement between the Ministry of Health and Long Term Care (MOHLTC) and CCO (the "Agreement"). The Project's agenda supports and informs the goals of the Ontario Cancer Plan (OCP) and is particularly in line with the strategic priority of developing and implementing innovative models of care. POC membership ensures alignment with other CCO and regional initiatives on planning, communication, and implementation issues.

RESPONSIBILITIES

- Set and approve strategic priorities for the Project that support and/or advance the deliverables of the Project as outlined in the Agreement
 - Lead policy development and act as the escalation point for issues related to the implementation of the Project
 - Consider innovative approaches to the implementation of the Project as brought forward by POC members and/or other stakeholders
- Oversee the execution of Project deliverables as set out in the Agreement and monitor performance
 - Advise on on-going activities to help ensure that the Project achieves its key objectives
 - Identify areas of focus and direct and approve the development, implementation and oversight of Project activities (e.g. CSRT integration, RFP process)
 - o Address issues that arise with the execution of the Project's implementation plan
 - Recommend and approve performance management and evaluation strategies for implementation
 - Oversee and advise on selection of measurement indicators and definitions
 - Advise on the development of sustainable funding models
 - Advise on the need for an ongoing oversight body upon completion of the Project
- Advise and plan strategic communications
 - Review and approve communication strategies and materials
 - o Ensure alignment with other CCO and regional initiatives
 - o Advise and approve government relations and stakeholder engagement strategies
 - Ensure information sharing with the Ministry and regions on planning and implementation matters
